Legislative Liaison Report

At the national level, recent AACC position statements include the following:

Direct to Consumer Testing, July 2015

AACC supports expanding consumer access to DTC laboratory testing services that have demonstrated analytical and clinical validity and clinical utility. It is important that individuals

learn more about their health status so they can become more involved in decisions affecting their wellbeing. AACC recommends that only CLIA-certified laboratories perform DTC testing and that such facilities provide consumers sufficient information and/or access to expert help to assist them in ordering and interpreting tests. Consumers should work with qualified healthcare providers in making decisions affecting their personal health.

Personalized Medicine, June 2015

AACC strongly supports efforts within the healthcare community to personalize patient care and improve individual patient outcomes. Laboratory medicine plays a vital role in enabling the practice of precision medicine, including the identification of drugs or interventions that are best suited for each individual patient. We urge policymakers and payers to adopt policies that ensure access to and appropriate reimbursement for laboratory testing that will facilitate personalized therapeutic decisions.

Laboratory Developed Tests, Nov. 2014

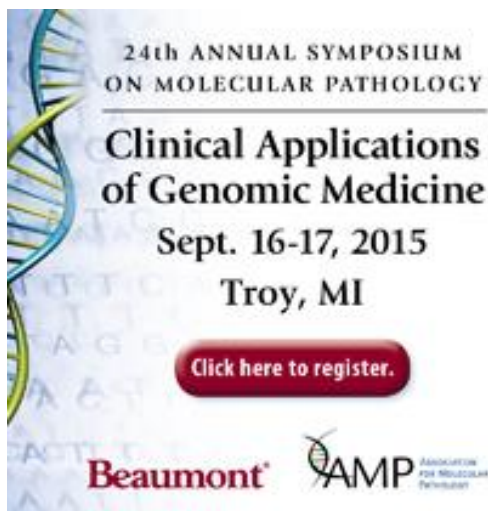
Laboratory developed tests (LDTs) provide timely, accurate, quality testing for many conditions for which no commercial test exists or when an existing test does not meet current clinical needs. The regulation of LDTs should remain under CLIA'88 and its deemed accreditation bodies, except for high risk tests that should be subject to both FDA and CMS oversight.

At the state level, there are no laboratory related bills pending in the Michigan State Legislature.
