The AACC, agrees to remit one half of the grant funds to the applicant or to the applicant's designated research project administrator at the grant start date upon submission of the "Agreement for Use of Research Funds from the AACC" The remainder of the grant funds shall be remitted to the applicant or to the applicant's designee upon the submission of a six-month interim progress report by the applicant.

Within thirty days of the end of the grant period specified in section V above, the applicant shall submit to the AACC, a full written report of research conducted under the grant, including a description of methodology and research findings and a complete accounting of the expenditure of grant funds. If results of this research are published in any format, e.g., journal articles, poster presentation, etc., it is agreed that there will be an accompanying notice that the research was supported by an AACC, Van Slyke Foundation Research Grant.

All grant funds unexpended at the end of the grant period shall revert to the AACC
