1. All air travel is coach or tourist, plus necessary ground transportation. (Rental cars are not reimbursable.) Travel must be made through AACC travel agent unless previously approved by Director of Meetings.

2. Per Diem = most available rate for single room at Headquarters Hotel plus an amount (approximately \$50) to be determined yearly to cover out-of-pocket expenses. Participation in programs held on the same or successive days will not result in two per diem payments for any one day. *The hotel payment will not be included if the speaker does not require a hotel room. Per Diem payments will be reduced if lodging is provided to the participant by AACC (i.e. AACC Officer or Organizing Committee).*

3. Additional per diem payments may be authorized by the Director of Meetings if a longer stay results in lower cost airfares.

4. The AMTF report states that honoraria "should be the exception rather than the rule."
